

**AVATAR PUBLIC SCHOOL-COIMBATORE**

Chairman, School Management Committee Shri. M Senthil Kumar has welcomed all members present for the meeting.

Following Agenda Points are submitted by the Member Secretary for the discussion and resolution there on:

**1. CONSTRUCTION OF SCHOOL BUILDING (EXTENSION TO THE EXISTING BUILDING):**

The SMC has reviewed the report submitted by the Construction Monitoring Committee. As per the report, construction will be completed by the end of May-2023 and ready to occupy for the year 2023-2024.

New Computer Lab and higher classes will function in the extended new building.

**2. ADMISSION FOR THE YEAR 2023-2024):**

The Principal has explained about the new admission cases and transferred out cases. SMC has suggested to follow new admission strategies for the next year and to minimize the transfer-out cases. Following points are discussed and resolved:

- a. Collection of Admission Fee
- b. Collection of Package Fee

It is decided to start Class-XI Admission followed declaration of result by the CBSE for the Class-X during the last week of May-2023.

**3. OTHER ACADEMIC POLICIES FOR THE YEAR 2023-2024):**

Following points are discussed in detail and resolved by the SMC which is to be implemented during the Academic Year 2023-2024:

- a. Artificial Intelligence Classes will commence from June-2023 onwards with the guidance of Whiz Club.
- b. Coimbatore Sahodaya School Complex inter school Chess and Spell Bee Competitions will be hosted by Avatar Public School on the dates assigned by them.

- c. It is decided to procure IFP for newly constructed Class Rooms.
- d. To enhance the quality of the teachers, training session will be given the month of May.  
External resource persons will be conducting the training.
- e. LSRW and Remedial classes will be strengthened.
- f. Talent expo will be conducted after nurturing the talents of the students.

**4. TRANSPORT FACILITIES FOR THE YEAR 2023-2024):**

To enhance the transport facilities to newly admitted children, it is decided to purchase more School Van and to appoint Drivers and Attenders for it.

SMC discussed the complaints received from parents, students and staff side.
